Program's General Terms and Conditions

"Mastercard Benefits Program" (the "Program")

- Mastercard Card. Maximum Cashback of Q\$7 (\$1.00 USD approximately) per month per Cardholder.

Cashback is a refund issued in the card account bank statement after the purchase transaction is posted and settled by the bank for the amount set in the above program mechanic.
